**NOTIFICATION OF EXCLUSION OF PERSONAL FIREARMS SECURITIES  
FOR THE DIMENSIONAL GLOBAL SUSTAINABILITY TRUST, DIMENSIONAL GLOBAL BOND  
SUSTAINABILITY TRUST AND DIMENSIONAL AUSTRALIAN SUSTAINABILITY TRUST**

DFA Australia Limited is the responsible entity of each of the Dimensional Global Sustainability Trust, the Dimensional Global Bond Sustainability Trust and the Dimensional Australian Sustainability Trust (together, the "Sustainability Trusts"), which take into account certain environmental and sustainability impact and social considerations ("Sustainability Criteria") when determining whether to exclude, underweight or overweight certain securities. DFA Australia Limited regularly reviews the criteria that it uses to measure environmental, sustainability and social matters in an effort to meet the needs of the investors in the Sustainability Trusts.

DFA Australia Limited as responsible entity of each of the Sustainability Trusts has determined to add personal firearms to the Sustainability Criteria for each of the Sustainability Trusts. As of the close of business on 9 May 2019, the Sustainability Trusts had no exposure to securities which met personal firearms criteria as determined by DFA Australia Limited. To illustrate this, a list of securities to which the Sustainability Trusts did not have exposure as of the close of business on 9 May 2019 is set out in the Schedule.

The Additional Information Guide which forms part of the Product Disclosure Statements for the Dimensional Global Sustainability Trust (dated 29 September 2017), the Dimensional Global Bond Sustainability Trust (dated 10 April 2018) and the Dimensional Australian Sustainability Trust (dated 21 November 2018) has been updated to reflect this change on or around the date of this notification. This change did not affect any other Dimensional Wholesale Trusts.
